The Victorian Curriculum and Assessment Authority (VCAA) has determined that Structured Workplace Learning (SWL) is a valuable component of all VET Delivered to Secondary School students (VDSS) qualifications undertaken.

VCAA strongly recommends that students undertake a minimum of 80 hours of SWL over the duration of the VDSS Certificate III in Early Childhood Education and Care (partial completion).


Students are required to complete 60 hours of practical placement per year (total 120 hours).
