

English Language Skills Registration Standard: Instructions for Applicant.

When you have finished your training you will need apply for registration as an enrolled nurse, which requires you to meet the Nursing and Midwifery Board of Australia (NMBA’s) mandatory registration standards and to practice within the relevant NMBA-approved standards, codes, guidelines, and frameworks.

To ensure that you can meet these requirements, the Victoria University Diploma of Nursing program has set an entry requirement for students interested in enrolling in the course. Before commencing the program, you must demonstrate that you have achieved the Nursing and Midwifery Board of Australia's specified level of English Language Skills.

To make things easier, the university has outlined three (3) different pathways that students can take to meet this requirement. You will need to:

- Read through these options.
- Choose a one of the three pathways that you are confident you can meet.
- Complete the section of the document that applies to your chosen pathway.
- Finally, you will need to fill in and sign the declaration at the end of the form.
 - Remember to submit the completed form as part of your application to the Victoria University Admissions Team.

Pathway 1 Choosing this option Complete Section A	Primary English pathway: English is your primary language and you have attended and satisfactorily completed at least six years of primary and or secondary education taught and assessed solely in English in a recognised country, including at least two years between years 7 and 12.
Pathway 2 Choosing this option Complete Section B	English Language Test Pathway You have achieved the required minimum scores in one of the following English language tests: <ul style="list-style-type: none"> → IELTS → OET → PTE Academic → TOEFL iBT You can confirm that the test results will be accepted if they were obtained within two years before the date of application and you can provide a copy of your test results.
Pathway 3 Choosing this option Complete Section C	Extended Education Pathway: You can provide evidence that you have successfully completed at least five (5) years (full-time equivalent) of continuous education taught and assessed solely in English, in a recognised country, which includes vocational and or higher education qualifications

Section B: Pathway 2 - English Language Test Pathway

You achieve the required minimum scores in one of the following English language tests and meet the requirements for **test results** specified in this standard:

1. the IELTS (academic module) with a minimum overall score of 7 and a minimum score of 7 in each of the four components (listening, reading, writing, and speaking).
2. the OET with a minimum score of B in each of the four components (listening, reading, writing, and speaking).
3. the **PTE Academic** with a minimum overall score of 65 and a minimum score of 65 in each of the four communicative skills (listening, reading, writing, and speaking).
4. the **TOEFL iBT** with a minimum total score of 94 and the following minimum score in each section of the test:
 - 24 for listening,
 - 24 for reading,
 - 27 for writing, and
 - 23 for speaking.

Section C - Pathway 3 - Extended Education Pathway

You can provide evidence that you have successfully completed at least five (5) years (full-time equivalent) of continuous education taught and assessed solely in English, in a recognised country that is a combination of:

- vocational and secondary education taught and assessed in English; or
- tertiary and vocational education taught and assessed in English; or
- combined tertiary, secondary and vocational education taught and assessed in English; or
- tertiary education taught and assessed in English.

The last period of education must have been no more than five years prior to applying for registration.
